CLIMATE / HOUSING / TRANSPORTATION

- 1) Modify *Maryland's Climate Pollution Reduction Plan* to reflect balanced energy policies that provide citizens multiple, reliable, and affordable energy choices.
 - a. The timeline for new and increased energy sources is out of sync with increased demand for electricity required by *Plan* mandates.
 - b. Mandates are excessively costly and unfairly limit citizens' right to choose where and how they live (e.g. all electric homes, electric vehicles only).
 - c. Zoning changes that would allow increased density or auxiliary dwelling units in communities of stand-alone single-family homes must remain with the local government authority, not be usurped by the State.
 - d. The plan will burden businesses (especially agriculture and manufacturing) with costly modifications, leading to higher prices for all.
- 2) Repeal annual Consumer Price Index increases to Maryland's motor fuel tax.
- 3) The new electric vehicle surcharge is less than a fair share of transportation construction and maintenance costs when compared to fuel tax paid by gas and diesel vehicles. A replacement (<u>not</u> additional) funding source is needed for the gas tax.

PUBLIC SAFETY -- Support for law enforcement and safety in our communities.

- 1) We support increased training for police officers in non-lethal methods of restraint and control of individuals or groups, including training for de-escalating tense or potentially violent demonstrations.
- 2) We "Back the Blue" Overzealous press and prosecutorial decisions have negatively impacted recruitment and retention, resulting in understaffing and reduced enforcement.
- 3) We must develop and implement effective tests for drug intoxication, distinct from alcohol intoxication. Statistics need to separate drug from alcohol intoxication.
- 4) We need to strengthen penalties for persons who:
 - a. Physically attack bystanders, police, or other protesters.
 - b. Set fires, destroy private or public property with graffiti or physical destruction, or participate in looting and theft during protests, demonstrations, or riots.
 - c. Use lasers or projectiles with the intent to obstruct or harm others.

ELECTION INTEGRITY

- 1) SUPPORT
 - a. Government-issued photo ID requirement for voter registration and voting
 - b. Vote count accuracy and security
- 2) OPPOSE -- Ranked choice voting and approval voting

CULTURE OF LIFE

- 1) SUPPORT
 - a. Protection for pain-capable unborn children as a compelling interest of the state.
 - b. Education and action to address the deadly rise in fentanyl trafficking and fentanyl overdoses.
 - c. More effective treatment (vs. incarceration) for opioid addiction.
- 2) OPPOSE
 - a. Physician-assisted suicide or "death with dignity" legislation.
 - b. All attempts to apply the "Right to Reproductive Freedom" constitutional amendment to gender affirming care or to restrict parental rights as they relate to reproductive care for minors.

EDUCATION

A Department of Legislative Services fiscal briefing in January 2024 projected that deficits directly attributable to the *Blueprint* will appear in 2025 and reach nearly \$2.9B in fiscal 2029.

- 1) SUPPORT
 - a. Altering the *Blueprint for the Future*. The plan does not require that students perform at grade level and adds extra layers of bureaucratic control. It limits parental involvement and does not require parental knowledge or consent for education, social and health services.
 - b. Fewer administrators / more teachers fewer consultants / more tutors.
 - c. Education reform emphasizing the basics, with the goal of every child performing at grade level.
 - MCAP proficiency rates for the 2023-2024 school year (grades 3-8):
 - Language arts 48.4%
 - Mathematics 24.1%
 - Reading -- 33% NAEP proficient 8th grade students (2022)
 - Science 23.9% MCAP proficient -- 5th grade students (2024)
 - d. School choice (vouchers, charter schools, home schooling).
 - e. Limit girls' competitive sports to biological girls. Disproportional muscle mass and other physiological advantages in trans-identifying males increase the danger of life-altering injuries and give trans-identifying males an unfair competitive advantage.
- OPPOSE teaching, counseling or promoting gender transition in schools, including agreements between Boards of Education and hospitals or clinics for "gender-affirming" counseling, treatments, or surgeries for children under 18 years of age.





TYPES of BILLS

Administration Bill – a bill introduced at the request of the Governor.

Bond Bill – a bill for a local capital project which, after consideration by the General Assembly, can be included in the capital budget bill. In general, bond bills are not individually adopted by the General Assembly.

Budget Bill -- a bill that consists of the Governor's proposed operating budget for the State for the next fiscal year. The Budget Bill becomes law on approval by both chambers. The Governor's signature is not required. The bill must be passed by both chambers seven days before the end of a session or the Governor must extend the session. (Art. III, Sec. 52(10), MD Constitution)

Capital Budget Bill – a general construction loan or bond bill that finances construction of State-owned buildings ("bricks and mortar"). The bill states the amount of State debt to be incurred and the projects to be funded. The Capital Budget Bill may not be acted on until the Budget Bill has been passed by the General Assembly.

Constitutional Amendment -- a bill that amends the Maryland Constitution. A Constitutional Amendment requires a 3/5 vote in each chamber and approval by the voters at the next General Election.

Cross-filed Bill – an identical bill that is introduced in both chambers.

Departmental Bill -- a bill introduced by a committee chairman at the request of the Executive Branch of State government.

Emergency Bill – a bill that takes effect immediately upon the Governor's approval. A bill marked as "emergency bill" must pass third reading with a 3/5 vote in each chamber.

Reintroduction Bill – a bill that was unsuccessful in a previous session and is reintroduced in the present session. In the upper left corner, the bill is identified as a reintroduction.

Snake – a bill or provision that has a hidden purpose.

THE LEGISLATIVE PROCESS

The legislative process, the mechanism through which the laws of Maryland are enacted, is dynamic and complex. One hundred and eighty-eight men and women are elected every four years to serve in the State's legislative branch to enact laws that protect the interest of Marylanders. Legislation introduced in the General Assembly is a legislator's response to the needs or desires of his or her constituency.

In Maryland, an idea or concept must pass through many processes before it becomes law. Citizens of Maryland must approach their legislators to introduce a bill. If the legislator agrees to sponsor the legislation, the bill is drafted by the Department of Legislative Services, reviewed by the legislator, and prepared for introduction. Bills or resolutions may be introduced in advance of regular sessions.

First Reading: When the session convenes, the Reading Clerk reads the numbers and titles of the bills being introduced and indicates the committee to which they have been referred by the presiding officer.

Referral to Committee: The committees meet daily during the session to receive testimony and act on bills referred to the committee. Since the legislature is instrumental in integrating public demands with public policy, citizens are encouraged to present their views on the proposed bills by mail or by personal appearance. Lobbyists representing organized interest groups, officials from State agencies, local government representatives, and other interested citizens speak at these hearings, to either oppose or support the proposed legislation.

The Department of Legislative Services prepares a fiscal analysis for each bill, and these fiscal notes are considered during the committee deliberations.

Second Reading and Floor Consideration: The bill is reported back to the floor by the committee with its recommendation (favorable, unfavorable, favorable with amendment, or rarely, no recommendation). If the bill is amended by the committee, a vote is taken on the amendment, and if passed, another vote is taken on the bill as amended. Committee action may be reversed, but this is infrequent.

Amendments can then be offered from the floor by any member. After all amendments are considered, the presiding officer orders the bill to be printed for its third and final reading.

Third Reading: The bill must be printed in its final version with all amendments included for third reading. No amendments may be presented on third reading in the bill's chamber of origin, and the bill must be passed by a majority of the elected membership.

Second Chamber: The procedure follows a pattern identical to that of the chamber in which the bill originated, except amendments may be proposed during third reading, as well as during second reading. If not amended in the second chamber, final passage may occur without reprinting.

THE LEGISLATIVE PROCESS

Consideration of Bills Originating in One Chamber and Amended in the Second Chamber: If amended in the second chamber, the bill is returned to the chamber of origin where a vote is taken on a motion to concur or reject the amendments. If concurrence is voted, a final vote is taken on the bill as amended, and action is complete. The bill is reprinted, or enrolled, to include the added amendments before it is presented to the Governor.

If the amendments are rejected, two courses of action are possible: 1) the amending chamber may be requested to withdraw its amendments or 2) upon refusal to withdraw the amendments, either chamber may request a conference committee to resolve the differences between the two chambers.

Conference Committee: Three members from each chamber are appointed to a conference committee by the presiding officers to reach a settlement on the proposed legislation. A report of a conference committee goes back to both chambers to be adopted or rejected without amendment. If the conference committee report is adopted, the bill is voted upon for final passage in each house. If the conference committee report is rejected by either house, the conference committee may be directed to reconvene, new members may be appointed, or the bill fails.

Presentation of Bills to Governor: Except for constitutional amendments and the budget bill, presentation of all bills to the Governor is mandatory. The budget bill becomes law upon its final passage and cannot be vetoed. Bills must be presented to the Governor within twenty days after adjournment of a session, and in the case of such bills, the Governor may veto within thirty days after presentation. If the Governor does not veto a bill, it becomes law. The Governor may not veto a constitutional amendment.

Veto Power: The power to override a veto resides with the legislature. If a bill is vetoed during a regular session, the veto message is considered immediately. If a bill presented after the session is vetoed, the veto message must be considered immediately at the next regular or special session of the legislature, except that the legislature during the first year of a new term may not override a veto. A three-fifths vote of the elected membership in each house is necessary to override a veto.

In this situation, the State agency met with the legislator to explain enforcement difficulties presented by the original wording. The parties agreed on wording that would accomplish the legislator's intent while addressing the agency's implementation concerns.

Education, Energy, and the Environment

Natural Resources - Recreational Crabbing License - Exemption

This bill authorizes a person younger than age 16 to catch or attempt to catch crabs for recreational purposes in the waters of the Chesapeake Bay and its tidal tributaries without a recreational crabbing license. **The bill takes effect June 1, 2023.**

Fiscal Summary

State Effect: The bill does not materially affect State finances. Any decrease in license fee revenue is expected to be negligible.

Local Effect: None.

Senate Bill 102

Small Business Effect: Minimal.

Analysis

Current Law:

Department of Natural Resources' Regulatory Authority

The Department of Natural Resources (DNR) is authorized to adopt rules and regulations to, among other things, (1) restrict catching and possessing any blue crab and (2) establish the methods by which blue crabs are taken. DNR also has authority to adopt regulations to establish conservation and management measures associated with its responsibility/authority to adopt fishery management plans for various species, including blue crabs.

Department of Natural Resources Regulations

DNR regulations require an individual who catches or attempts to catch blue crabs for recreational purposes in the waters of the Chesapeake Bay and its tidal tributaries to pay a fee and obtain a recreational crabbing license in order to use the following gear to catch blue crabs: a trotline, collapsible traps or net rings, seines, and up to 10 eel pots for catching the individual's own bait. The annual fee for a recreational crabbing license is \$5 for a Maryland resident; however, if the Maryland resident has a Chesapeake Bay and coastal sport fishing license or a resident consolidated senior sport fishing license, the annual fee is \$2. The fee for a nonresident is \$10. A recreational crabbing boat license is also available, for an annual fee of \$15, which authorizes individuals in the licensed boat to catch or attempt to catch blue crabs in the Chesapeake Bay and its tidal tributaries using a trotline or collapsible traps or net rings.

An individual is not required to have a recreational crabbing license if the individual uses any of the following gear: a dipnet, a handline, or up to two registered crab pots if the person using the crab pots is an owner, lessee, or tenant of a private property along the shore, or a guest of an owner, lessee, or tenant of a private property along the shore. An individual assisting an individual who has a recreational crabbing license or an individual crabbing for recreational purposes from a boat licensed as a recreational crabbing boat is also not required to have a recreational crabbing license. An unlicensed individual, however, is subject to more restrictive daily catch and possession limits than a licensed individual.

MISCELLANY

ADDITIONAL DEFINITIONS

- Interim the 9 months between legislative sessions
- Fiscal year July 1 to June 30
- Legislative Day length of time from convening a session in the chamber until adjournment – may be longer or shorter than a calendar day (i.e., a session that continues into a 2nd calendar day without adjourning is one legislative day). If a chamber adjourns and reconvenes on the same day, that constitutes two legislative days.
- MGA Maryland General Assembly 47 senators + 141 delegates
- Sine Die the final adjournment of a session, without adjourning to a specific time or date [from the Latin *sine* (without) + *die* (a day) → "without a day"]

BOARD of PUBLIC WORKS

The Board of Public Works (composed of the Governor, the Treasurer and the Comptroller) is charged with protecting and enhancing the State's fiscal integrity by ensuring that significant State expenditures are necessary and appropriate, fiscally responsible, fair, and lawful. They review and approve capital projects, procurement contracts, and the acquisition, use, and transfer of State assets.

BUDGET

Budget powers are defined in Article III §52 of the Maryland Constitution. The Governor sets the revenue estimates that establish the basis for State spending. The Governor's budget proposal includes all planned expenditures for the fiscal year and is presented as both a budget bill and in detailed budget book volumes.

The State operating budget must be balanced when the Governor submits it to the General Assembly (on or about the 3rd Wednesday in January or by the 10th day of the Legislative Session in the first year of a new term) and when the General Assembly approves it. The General Assembly can cut but cannot add to the Operating Budget. The operating budget bill cannot be vetoed by the Governor and becomes law immediately upon final passage, with no further action by the Governor. The Governor may, with the consent of the General Assembly, amend or supplement the budget to correct an oversight, to fund pending legislation, or to address an emergency.

STATUTE vs. REGULATION

Annotated Code of Maryland

Statute is written law passed by the legislative body. The Annotated Code of Maryland, published by The Michie Company, is the official codification of the statutory laws of Maryland. It is organized into 36 named articles.

Code of Maryland Regulations (COMAR)

Regulations usually must be authorized by a statute, and are subordinate to statutes, but have the same legal force as statutes. They are used by state agencies to implement, interpret, or make specific the statute or the Department's procedures to meet the law. Regulations carry the force of law.

BILL LINGO

Adopt -- approve an action (i.e., an amendment, committee report, motion)

Amend – make a change to a bill or a law

Bill -- a proposed law presented to the General Assembly for consideration

Bill number -- assigned to a bill at the time of introduction and retained throughout the legislative process

Concur -- one chamber approves an action taken by the other chamber

Drop into "the Hopper" -- a member files a bill with the Chief Clerk of the House or the Secretary of the Senate for introduction

Enacted -- when the bill becomes a law (i.e., is signed by the Governor and takes effect)

Enrolled (Passed Enrolled) -- a bill that was amended in the opposite chamber

Failed -- a bill does not receive a majority vote on the chamber floor

Joint Resolution -- a resolution both chambers pass making a statement on a public issue, a request of the Governor or a government office, or establishing a task force. With certain exceptions, Joint Resolutions do not have the effect of law. Before it becomes a resolution, it will be given the designation SJ (Senate Joint Resolution) or HJ (House Joint Resolution). When agreed upon by both chambers, they become a JR (Joint Resolution).

Laid over -- floor action on an amended bill is postponed for one legislative day

Pre-filed -- a bill the Department of Legislative Services drafts, by request, prior to a legislative session for introduction in that session

Reassigned -- assignment of a bill from one committee to another

Referred -- the action of assigning a legislative measure to a committee or committees

Re-referred -- the reassignment of a bill to a different committee after the original referral

Reject -- the failure of an action (i.e., an amendment)

Returned passed -- a bill passed in its chamber of origin is returned by the opposite chamber without amendments

Special Order -- postpones floor action on a bill until a definite date or time

Sunset provision -- provides that a provision of the law is automatically repealed on a specific date, unless the General Assembly reenacts the law

The Chair -- the presiding officer of a chamber or of a committee

The Floor -- that portion of the chamber reserved for members and officers of the assembly or other persons granted access.

Veto – the action the Governor takes to prevent enactment of a bill passed by the General Assembly. At the next session the General Assembly may override the Governor's veto with a 3/5 vote in each chamber (except in an election year when overrides are not feasible).

2025 TESTIMONY TIPS

While the rules for submitting testimony are consistent across all committees, committee chairs have some flexibility in the rules for their committee. This may mean that the amount of time allowed for testimony or the number of individuals allowed to testify may be limited in the last weeks of Session. You should check the MGA website for any procedural changes in the committee in which the bill will be heard.

- Thoroughly read the bill and the Fiscal Note.
- Check to see if an identical or similar bill was introduced last year. If so:
 - Did the bill get out of committee?
 - How did the members of the committee vote?
- Contact Republican committee members before the hearing, if possible.

ORAL TESTIMONY

- Prepare an outline of main points or write out your entire testimony.
 - State name, organization (if speaking on their behalf), and bill number
 - State your position and why -- provide extra details, charts, or amendments in written form (refer to them in oral testimony).
 - Support -- *I support HB1234 because* [give reasons -- facts, statistics, etc.]
 - Oppose -- I oppose HB1234 because [give reasons -- state problems or damage the bill would cause and who or what would be damaged).
 - Support with Amendments I oppose this bill in its present form because [state objection]) but can support [or not oppose] if amended to incorporate [restate desired change].
 - Close with:
 - If "Support" I urge the committee to give HB 1234 a favorable report.
 - If "Oppose" I urge the committee to give HB1234 an unfavorable report.
 - If "Support with Amendments" I urge the committee to amend HB1234 to [restate your recommended change(s)].
 - Thank the committee for the opportunity to testify.
- Practice and time yourself (generally limited to 2-3 minutes depends on the committee).
- Be respectful, polite and cordial.
- If you don't know the answer to a question from the committee, respond: *I don't know the answer to your question, but I will check on it and provide an answer to the Chairman as soon as possible.* Be sure to follow up.

SENATE COMMITTEES

<u>Budget & Taxation</u> (B&T) considers legislation relating to State operating and capital budgets, including revenues, expenditures, and supplementary appropriations; legislative budgetary procedures; State and county bond authorizations; taxation and property assessments; education; financing; and pension and retirement matters.

<u>Education, Energy and the Environment</u> (EEE) reviews legislation concerned with agriculture and land preservation; alcoholic beverages; and the licensing and regulation of businesses and labor, including business, health and related occupations and professions. The Committee also evaluates bills relating to education policy; elections; energy; environment; ethics; fire prevention; local government; natural resources; procurement; State government organization, procedures and administrative law; and veterans affairs.

<u>Executive Nominations</u> (EXN) reviews and interviews gubernatorial appointees for all appointments made by the Governor which require Senate advice and consent. The Committee then reports its recommendations on those nominations to the Senate.

<u>Finance</u> (FIN) – reviews legislation on banking and financial institutions; credit regulation and consumer financing; economic and community development; and health and welfare matters. It also considers bills concerned with horse racing and lotteries; insurance; labor and employment; State personnel issues; social programs; transportation; unemployment insurance; utility regulation; and workers' compensation.

MAKING YOUR POSITION KNOWN

<u>Judicial Proceedings</u> (JPR) is assigned legislation relating to the Administrative Procedures Act; commercial code; constitutional amendments; corrections; criminal and civil laws, penalties, and procedures; equal rights and opportunities; ethics; family law; and judicial administration and court structure. The Committee also reviews bills on juvenile justice; landlord and tenant laws; law enforcement organizations; legal profession; legal rights and immunities; public safety; real property; trusts and estates; and vehicle laws.

<u>Rules</u> (SRU) considers proposals regarding rules, organization, and procedures of the Senate or the General Assembly. The Committee reviews proposed legislation introduced after the bill introduction deadline in a regular session and determines which of those bills it will refer to the Senate's standing committees.

HOUSE COMMITTEES

<u>Appropriations</u> (APP) is the House budget committee. It reviews legislation relating to State operating and capital budgets, including supplementary appropriations; State and county bond authorizations; collective bargaining; fiscal procedures; higher education; State personnel and pension matters; and social services.

<u>Economic Matters</u> (ECM) considers legislation relating to alcoholic beverages; banks and other financial institutions; commercial law; corporations and associations; economic development; electronic commerce; licensing and regulation of businesses, including related occupations and professions; labor and employment; property and casualty insurance; unemployment insurance; utilities, including electric, gas, and telecommunications; and workers' compensation.

<u>Environment and Transportation</u> (ENT) is assigned legislation relating to agriculture; bi-county agencies; environmental matters, including agricultural land preservation, Program Open Space and vehicle emissions; ethics; local government; motor vehicles; natural resources; real property and housing; and transportation (non-revenue related).

<u>Health and Government Operations</u> (HGO) considers legislation relating to child and elder healthcare; civil rights; emergency medical services; health and life insurance; health policy and planning, including facilities, occupations, and public health; long-term care; and State government organization, procedures, and administrative law, including procurement.

<u>Judiciary</u> (JUD) considers legislation relating to courts and judicial proceedings. It also is concerned with administrative law; corrections; criminal and civil laws, penalties, and procedures; drunk and drugged driving; estates and trusts; family law; juvenile cases; the legal profession; legal rights and immunities; and jailable motor vehicle offenses.

<u>Rules and Executive Nominations</u> (HRU) considers proposals concerning the rules, organization, and procedures of the House and the General Assembly. The Committee reviews legislation introduced after the bill introduction deadline and decides on re-referral of those bills to other standing committees for consideration. In addition, the Committee examines gubernatorial nominations requiring House confirmation and reports its recommendations.

<u>Ways and Means</u> (W&M) is responsible for legislation relating to children, youth and families; education funding, including primary and secondary education, community colleges, and scholarships and financial aid; election law; gaming and horseracing; State and local taxes; and transportation funding and revenues.



- The Governor's spending plan leaves a general fund balance of \$106 million at the end of fiscal 2026.
- The Revenue Stabilization Account (Rainy Day Fund) ends fiscal 2026 with a balance of \$2.1 billion (8% of general fund revenues). Combined cash balances at the close of fiscal 2026 of \$2.2 billion equal 8.4% of general fund revenues.
- Ongoing spending in the fiscal 2026 allowance exceeds ongoing revenues by \$186 million, falling short of the Spending Affordability Committee's (SAC) goal of eliminating the projected \$2.5 billion structural deficit.
- General fund spending declines due to cost containment efforts and the fiscal 2025 budget including \$268 million to pay fiscal 2024 costs that could not be absorbed in the fiscal 2024 budget. Proposed Budget Reconciliation and Financing Act (BRFA) reductions that relieve mandates save \$939 million in fiscal 2026.
- Federal spending declines in fiscal 2026 due primarily to lower federal Medicaid claims reflecting fiscal 2025 spending on fiscal 2024 bills. Growth in special fund spending is spurred by a \$543 million increase in the Blueprint for Maryland's Future Fund (Blueprint Fund) spending on education, a \$343 million increase in spending for transportation including a \$90 million increase in support for the State Climate Pollution Reduction Plan, and more than \$160 million of additional higher education spending from own-source revenues (tuition and fees, federal grants and contracts, etc.).
- The Administration's budget plan includes revenue and spending adjustments with a combined general fund impact of \$2.965 billion that are contingent on legislation.

Maryland's FISCAL 2026 BUDGET

(Republican analysis)

How did the State go from a \$5B+ surplus left by Governor Larry Hogan to a \$3B+ deficit in two short years?

Governor Wes Moore is addressing a \$3B+ deficit in his FY2026 Budget with \$1B in new revenues (tax and fee increases), \$500M from the State's Rainy Day Fund, and \$2B in cuts and government efficiencies.

NEW REVENUES (taxes and fees)

- Imposes a new <u>delivery tax</u> -- adds a \$0.75 fee to every online purchase that will automatically increase each year because the fee has been tied to the CPI (Consumer Price Index).
- Eliminates all <u>itemized</u> income tax <u>deductions</u> qualifying medical and dental expenditures, home mortgage interest, real estate taxes, charitable contributions, forcing everyone to claim the standard deduction.
- Modifies the <u>child tax credit</u> to phase out benefits gradually.
- Doubles the vehicle emissions inspection fee -- from \$14 to \$30.
- Eliminates <u>trade-in credit</u> when calculating tax on a vehicle purchase over \$15K. Average trade-in value in Maryland of \$20K = \$1,200 tax increase.
- Accelerates increases in <u>vehicle registration fees</u> the General Assembly passed last year.
- Establishes an administrative fee for Marylanders who need to pay the higher <u>vehicle registration fees</u> in installments.
- Establishes a 4-year surcharge on <u>capital gains income</u> over \$350K.
- Increases the income tax rate for the 3 lowest tax brackets and the 2 highest brackets.

 Increases the <u>income tax rate</u> on Maryland millionaires to 6.5% and imposes a 1% <u>capital gains tax</u> every time a stock or other security is sold.

Governor O'Malley's 2008 Millionaires' Tax increased the income tax on Maryland residents with incomes over \$1M to 6.25%. One year later: 30% drop in the number of millionaires with principal residence in Maryland -- predicted \$106M income tax gain for the State became a realized <u>loss</u> of \$257M. Another "exodus of the wealthiest" will create a hole in the State budget that those remaining will have to fill through higher taxes and fees – again!

- Lowers the point at which Maryland's 16% <u>estate tax</u> is levied from \$5M to \$2M. It won't take much to reach the \$2M level when you consider the value of your home, vehicles, IRAs and 401Ks, pensions, and other assets.
- Doubles the tax on <u>sports wagering</u> -- from 15% to 30%.
- Increases the tax on table games at Maryland casinos -- from 20% to 25%.
- Increases the tax on <u>cannabis sales</u> -- from 9% to 15%.

Governor Moore is using taxes and fees to close a deficit largely attributable to budgetbusting bills that the General Assembly has passed in recent years despite Republican opposition.

Below are just 3:

- Blueprint for Educational Excellence (Kirwan) has no dedicated funding source and will cost the State tens of Billions of dollars to implement. By the end of this decade, it is projected that the State deficit will be \$6.5B, thanks in large part to the costs of the Blueprint.
- **Climate Solutions Now Act** had no cost analysis at the time it was passed and will cost the State over \$1B a year to implement.
- Child Victims Act of 2023 vastly expanded the ability of those alleging child sex abuse to sue the State of Maryland as the employer of their alleged abusers. Recent disclosures projected the Act could cost the State over \$3.1B.



Kunta Kinte-Alex Haley Memorial at the City Dock

The Memorial consists of 3 distinct areas: the Alex Haley sculpture group, Compass Rose, and Story Wall. It portrays in word and symbol the triumph of the human spirit in very difficult times and conveys Haley's vision for national racial reconciliation and healing. It is the only memorial in the country commemorating the actual name and place of arrival of an enslaved African.

Maryland State House - State Circle

The Maryland State House is the oldest state capitol in continuous legislative use and the only state house to have served as the nation's capital. The Continental Congress met in the Old Senate Chamber from November 26, 1783 to August 13, 1784. During that time, George Washington came before Congress to resign his commission as commander-in-chief of the Continental Army and the Treaty of Paris was ratified, officially ending the Revolutionary War.

<u>St. John's College</u> is a private liberal arts college. It is the third oldest college in the United States (reportedly behind Harvard, established in 1636, and College of William and Mary in 1693). In 1937, St. John's adopted a Great Books curriculum based on discussion of works from the Western canon of philosophical, religious, historical, mathematical, scientific, and literary works. The college grants a single Bachelor's Degree in Liberal Arts. Since 1983, the "Johnnies" have hosted an annual croquet match against the U.S. Naval Academy Midshipmen.

Thurgood Marshall Memorial -- Lawyers' Mall - State House Square

This memorial honors the great civil rights leader who became the first African-American to serve on the U.S. Supreme Court. The memorial is erected on the site of the old Court of Appeals building where Marshall argued some of his early civil rights cases.

<u>U.S. Naval Academy</u> – 90-minute walking tour – available at 10 am, 11 am, 1 pm and 3 pm Available for groups of less than 15 people -- requires no advance reservations. Expect to visit all the historical and monumental highlights, get the inside scoop on admissions and learn about the midshipmen experience. Tickets available only in-person/same day at the Information Desk inside the Visitor Center.
